# Presidents Report 2021

I think the 2021 will go down as one of the hardest I have I have had to deal with as far as leading the administration of our Society. What should have been a very easy term because of no activity within the Square Dance movement, this was more than offset by the task of making us comply with the registered constitution and well as formalizing what we actually do.

How we got into this situation has not been established as the Society was never ever registered to operate under the "Model Rules".

I have personally spent more time than I would have wished, dealing with Consumer Affairs Victoria.

This was by way of numerous phone calls (too many to mention) and even personal visits to the City Office.

Dealing with Bureaucracy is not easy and this is still ongoing.

I have Personally logged a Freedom of Information claim against the CAV.

The specific questions asked are: -

- 1. When did the Society revert back to the "Model Rules"? and
- 2. Who lodged the change?

There has been so far no response.

In order to make us compliant again, there were several options looked at.

These included looking an Incorporating in a different State.

Copies of Incorporations Act from NSW, ACT, QLD & SA were looked at.

It was decided that the line of least resistance would be to continue with the Victorian "Model Rules" being used as a base, and changing just those clauses that represent the way we actually operate.

This is what is in the proposed amendment.

These will no longer be the "Model Rules" but with (upon being accepted) become "Our Own Rules".

The amount of work that had to be done to get to this stage has been enormous, far more than I (and most people) would have expected.

Firstly, we had to establish who was actually Members.

I must thank Graham Burgan here, for the enormous amount of research and suggestions in establishing this.

This was taken to the CAV who gave their approval.

Secondly, we had to see what clauses needed to be modified to suit or operation.

All very simple when it is condensed down like this. But believe me, it wasn't

What we have to present, is what we have come with, It will no doubt need tweaking as it is almost impossible to get it right the first time.

You can have 10 people read it and could have 10 different interpretations.

However, future committees may wish to change it to suit the ongoing needs of the Society.

A big gratitude of thanks to Celia Karas, Graham Burgan and Alan Hansford and specifically to Ros Todd, who without her level headedness and support I would have walked away from it all.

In closing, I would also like to thank our executive committee, who were always there to offer support.

As I now have the big Eight Zero in my sights, with my hearing making it difficult to enjoy Square Dancing as I once did, it is perhaps time to start winding back.

But as the next term will only be a short one (Until February) I would

be interested in renominating so that I can see these current issues resolved. Should it be the Members wish.

If not, Then I pledge to make myself available, should there be any assistance needed.

Thank you all for your patience and understanding during this difficult Period.

The Review currently has 660 subscribers and is made available through the National website. Of these there are 57 overseas subscribers. New South Wales continues to print 140 copies of the magazine which includes the quarterly Australian Square Dance Review. A number of states have links to the Review via their state websites.

It is pleasing to note that state presidents usually present a report in most issues and that information is received from the National Associations during the year.

Advertising, whilst a minimal cost, is rarely taken advantage of and I receive constant requests for bank details when I indicate payment needs to be made in advance.

The Guidelines for the Electronic Review which is to include the Special Edition of the Review has now been completed and has been sent to states who have indicated that they have a state editor.

In closing, my thanks go to those who assist in compiling information for the Review and to Kevin Thomas for uploading the Reviews both past and present.

# National Square Dance Society of Australia Public Relations report to AGM 26th September 2021

Listed below are the numbers of calls received for the last four years on the 1800 line. I have left in the previous 3 years figures to give you a comparison.

As in the past, we are using our personal landline and mobiles for outgoing calls at no cost to the Society. The total cost for the last 17 months has been \$1023.06. This is an average of \$60.18 per month against \$62.58 last year for the line and 1800 service combined

Payments for our 1800 service and the landline are still on autopay and twice a year, The "Account" is topped up by our treasurer with \$400. This system is still working well.

If you are using the 1800 number in your advertising, PLEASE LET ME KNOW. It is quite embarrassing and unprofessional when I do not know what a caller is talking about.

As you can see, there is not that much activity considering this is a 17 month period. However, the calls I do get leave people very happy that they have got on to a real person.

Because of all the scam calls we are getting, we have stopped answering the 1800 service after about 7.00 pm. However, we always check it before retiring and handle the call the next morning if necessary Most genuine calls come in during the day.

If there are any changes to your state contact details for 1800 call purposes, please advise me of the necessary alterations.

# Promotions Sub Committee Report to December 31 2020 AGM 26<sup>th</sup> September 2021

During 2020 the Promotions committee with ratification from the National Society completed the following tasks:

### **National Square Dance Day**

The last Sunday in February to be the designated day when all states demonstrate square dancing. The content of the day be up to individual state societies/clubs. Unfortunately as a result of the Covid pandemic states have been unable to proceed with this event.

A designated space on the National website has been set up for promotional resources which can be utilised by square dancers and can be found at <a href="https://www.squaredanceaustralia.org/promotion-resources/">https://www.squaredanceaustralia.org/promotion-resources/</a>. Some of the resources available include:

### **Flyers**

There are four flyers available on the website available for download that can be personalised with contact details of the user.

There are also some advertising flyers submitted by Don Barba WA as an ideas resource.

#### **Radio Advertising**

After a lot of persistence from Brenda Cockburn two radio ads were produced by Purple Wax which are now on the website for usage. These ads are available to use on radio stations and are not suitable for television. Individual radio stations may charge for air play. There was an additional \$60+ GST charge as a result of changing the ad from .com to .org on the male version ad. These ads were produced at a cost of \$300 + GST.

#### Video

There are currently three videos on the website of varying lengths. Some have Australian content these were supplied courtesy of Greg Fawell WA.

### **Meet-Ups**

Sasha Boon conducted a training session to set up Meet Ups for state & territory delegates. Events had been set up for Perth and Launceston. There can only be three events running at a time on the Meet Ups platform. Sasha completed additional training for the Perth delegates.

This platform relies on someone attending the new dancer event to welcome new dancers and check on the people who actually attend the event as a result of Meetup.

#### **Three Year Plan**

Four volunteers from the sub-committee have been discussing and working on a three year plan for promotions which is ongoing.

### **Update 2021**

As a result of the continuing Covid-19 pandemic progress on the Promotions committee has slowed.

In May 2021 I emailed all states to assess their interest in working together to utilise the radio ads on community radio through the Community Broadcasting Association of Australia. New South Wales, Victoria and South Australia came on board and a promotion was planned for June and July 2021. Whilst the timing was not ideal due to the Delta strain outbreak in NSW it put the word out about square dancing. We were provided with two interviews along with the playing of the two radio ads. The first interview was done with Kevin Walsh from Good Morning Country and David Todd, President SARDA NSW. The second interview with Sasha Boon, Secretary VSDA, and Julie from Saturday Breakfast.

These ads were broadcasted across thirty-eight radio stations (6 in Victoria, 3 in Tasmania, 4 in South Australia, 4 in Queensland and 21 in NSW) and reached an estimated audience of 348,000 listeners each week. The ads were played 1134 times with a preference to the female version of the ad. The 1800 number received one call as a direct result of this promotion.

Our next project is to work on an app for square dancing. This project is in its early stages so there is nothing further to report.


There are a limited number of leaders who utilise the function of this page to promote to new dances. Both administrators repost new dancer information from other pages as appropriate and answer any enquiries.

This page is also linked to the National Society webpage.


Below are some of the statistics that this page generates:


### Age and Gender




### Results from March 19 to September 2021











# SquareDanceAustralia.org Web-Coordinators Report 2021

Over the past year, after discussions at our General meetings. The website has been all placed under one domain name (suaredanceaustralia.org)

This will prevent the confusion of parts of it being on different domains. The other domains have been parked and anyone accessing them will be given a message to update their Bookmarks to the current domain.

There has been some work done to try and reduce spam emails coming via the website. We have now installed reCAPTCHA and Honeypot to filter out Bots. (Non-Humans)

I have reviewed the current by-law (Schedule 04. 01) on Website Operations Guidelines.

It is 24 years (Newcastle 1997) since the current Guidelines were written and much has changed since then.

The current Guidelines are very comprehensive and includes duplicates of duties and actions that are covered by our general rules of operation. These I am proposing to remove.

Technology has also changed and references to terms used are no longer current or do not need to be in any guidelines.

The pricing section is no longer relevant as it included a subscription for affiliates and clubs.

As we have been fortunate to get donations marked for website support.

With this in mind, this has been reviewed and the number of pages has been reduced from 10 pages to 4 the pages.

I would like to put this forward as an Agenda Item for 2021 Annual General Meeting.
